# State Reports of Hot Topics, Greg Durrell

<u>Alabama</u> – See report in meeting packet

<u>Arkansas</u> – Planning an outreach program to universities and colleges. They met with architecture and interior design students

<u>Florida</u> – AIA FL recently had their Legislative Day. The board is down three architect members. There is talk of abolishing building departments, while some find it a positive move, it is unrealistic.

<u>Georgia</u> – AIA GA Grassroots day is coming up. They are looking to update the rules and regulations.

<u>Louisiana</u> – See report in meeting packet.

Mississippi- See report in meeting packet

<u>North Carolina</u> – Published guidelines on design/build and the board is working with AIA NC to design a CE program based on the guidelines. SB 488 has made negative impacts on HSW – there are no longer seats for architects on the Building Code Council. Still no building code update, after seven years.

<u>Puerto Rico</u> – Proposed law that seeks to change various rules and regulations for their Board that will have a huge impact on practice and HSW.

South Carolina – Possibly adding interior design legislation.

<u>Tennessee</u> – Allocated money to be split among the design profession programs at TN universities and colleges for research.

<u>Texas</u> – Legislature is in session, there are some pending bills that may impact budgeting. They are planning outreach to universities and colleges.

## MBE Report, Tyson Ducote

Mr. Ducote reported on the MBE Workshop activities. The MBEs had an open forum to discuss various topics of interest. There was a presentation on the Pathways to Practice as well as a session that introduced NCARB staff members and described their functions.

## **Regional Officer Elections**

After opening the floor for additional nominations and hearing none, the candidates were given three minutes to speak about their candidacy. Ms. Monte Carlo-Evans passed out ballots to the voting delegates, collected them and with Mr. Ducote counted the ballots. The results of the FY 26 Executive Committee election are as follows: Cathy Morrison, Regional Director Greg Durrell, Chair Pedro Alfaro, Vice Chair Darren James, Secretary/Treasurer Lance Brenton, Member Board Executive to the Board of Directors, with an uncontested race, the Region 3 MBEs in attendance, of which there was a quorum, elected Mr. Brenton by acclamation.

### **Regional Director's Report**

Mr. Rodriguez reported that the NCARB BOD took a deeper dive related to the Pathways to Practice. The BOD reviewed the resolutions pending for FY25. They have done a preliminary budget review but will approve it at the FY 26 BOD meeting in June 2025. Mr. Rodriguez expressed his gratitude for the Region's support.

Ms. Morrison presented a Distinguished Service award to Kevin Singh for his service as one of the first At-Large members of the NCARB BOD.
